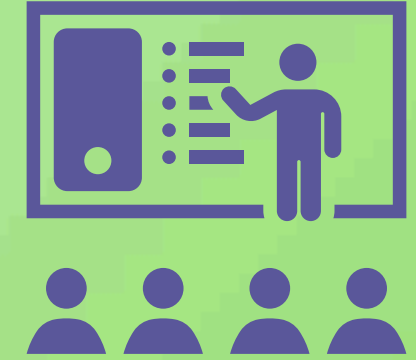

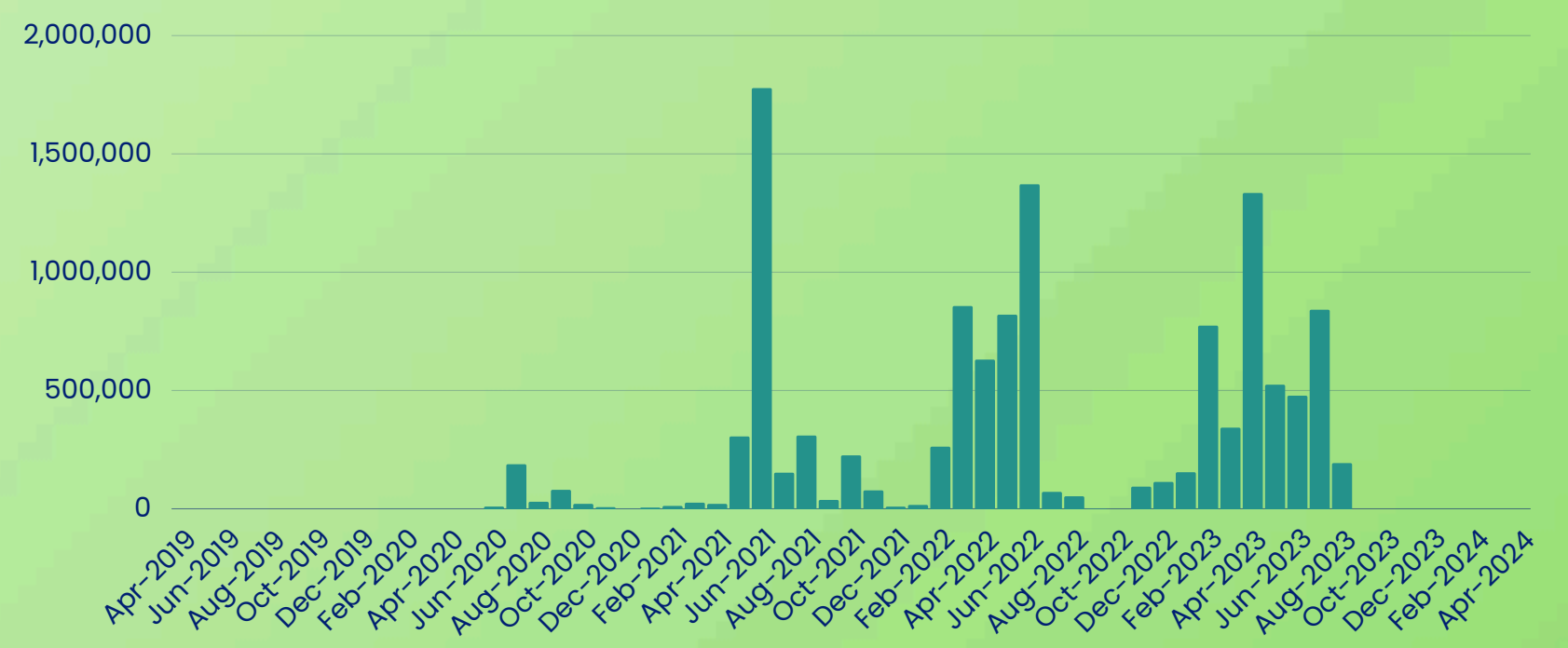




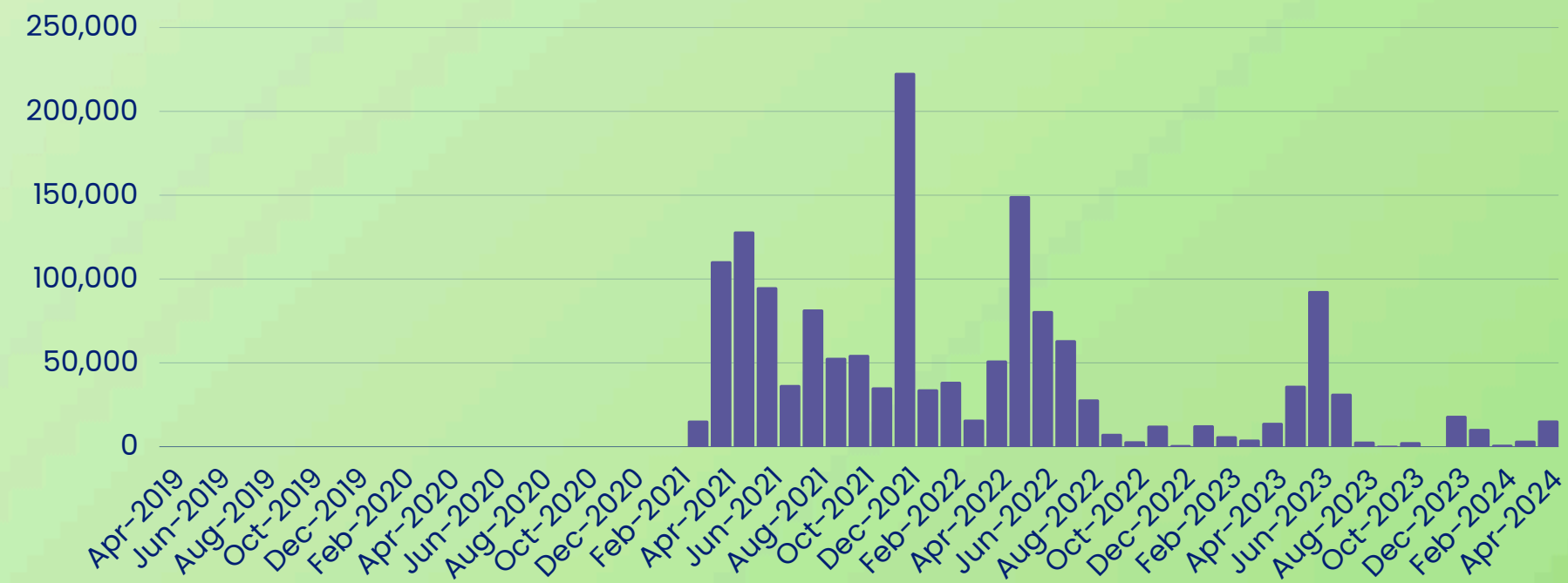
Region & month wise plantation



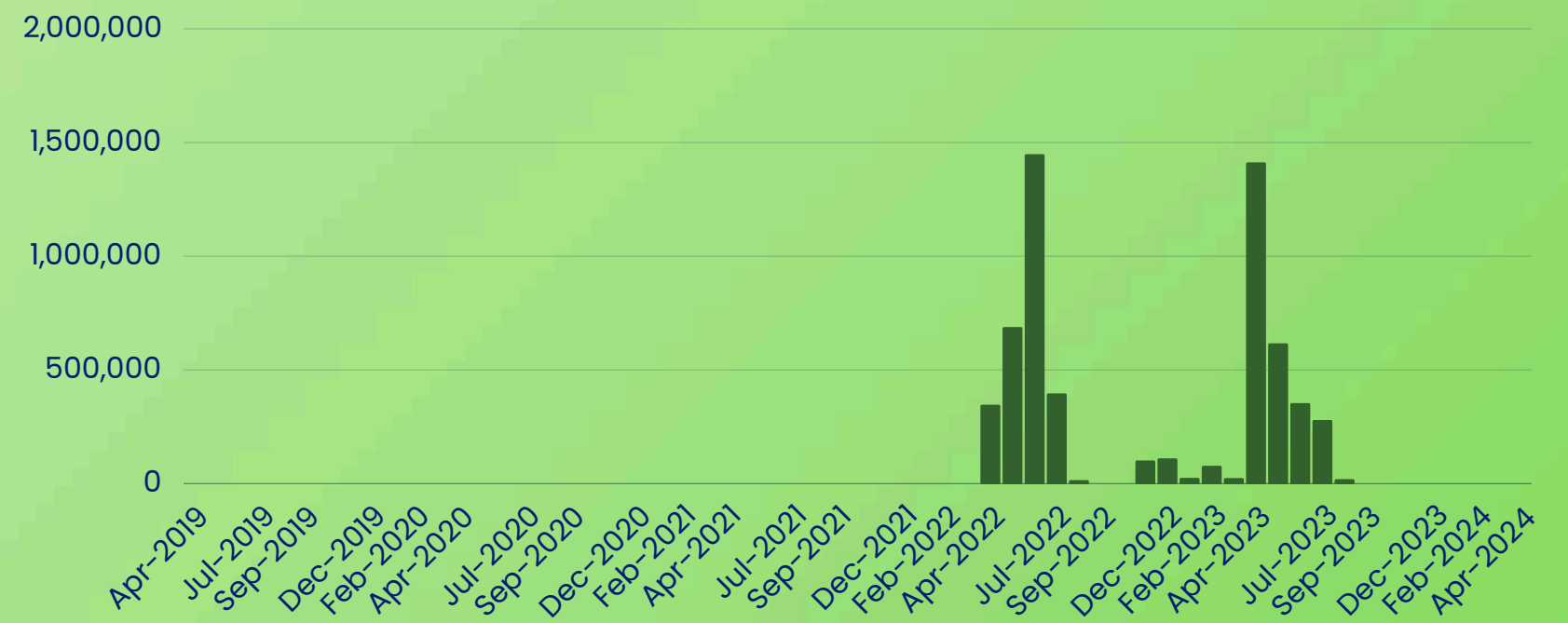
Month wise plantation (Marathwada) (April 2019-April 2024)



Month wise plantation (Madhya Pradesh) (April 2019-April 2024)



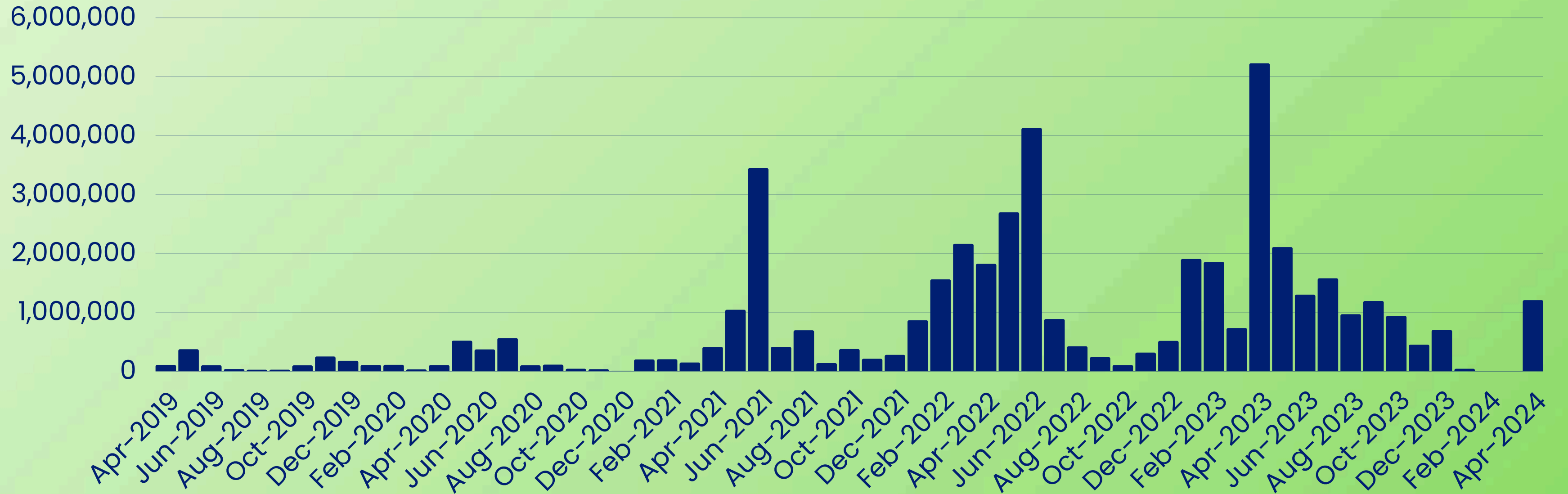
Month wise plantation (Palghar) (April 2019 - April 2024)

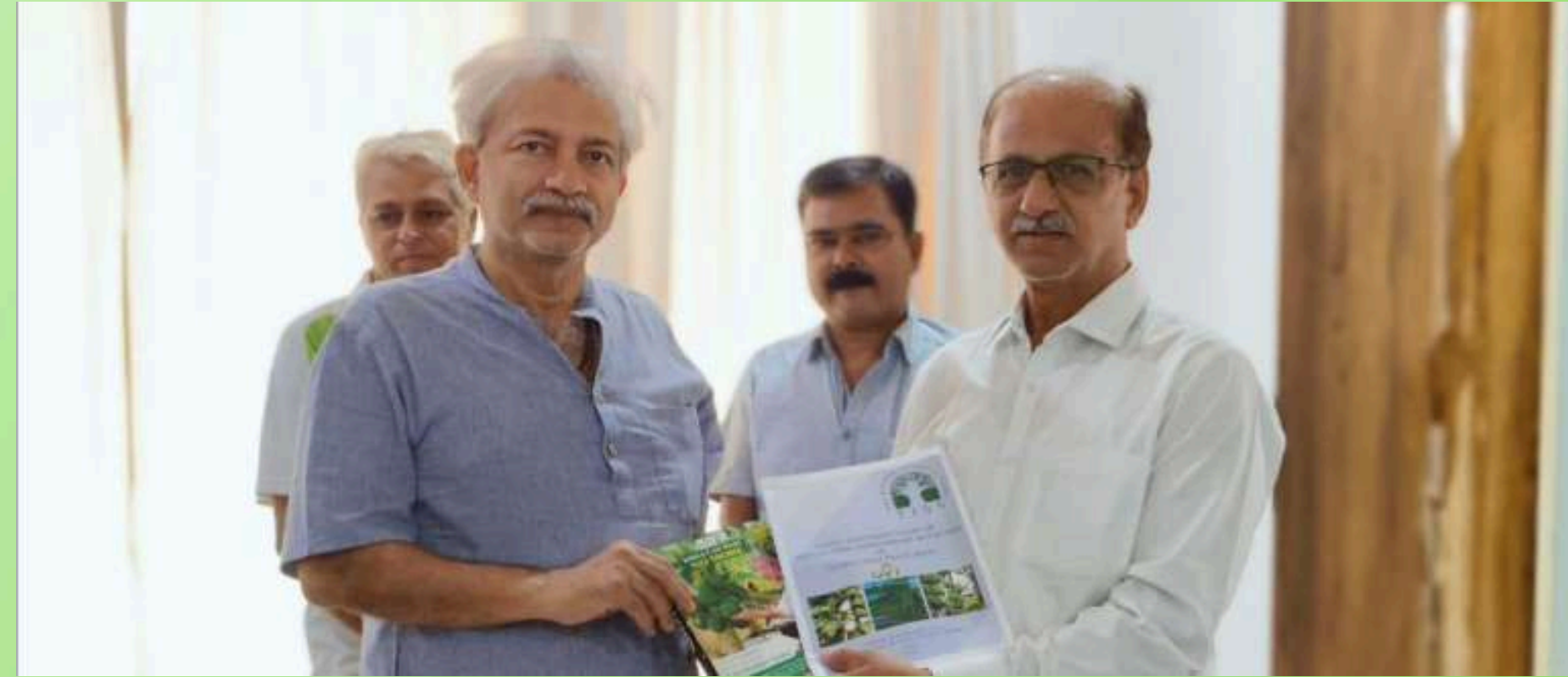
Noteworthy Event (Marathwada)

Guest Visit by Dr. V.D. Patil, Associate Dean of the agricultural college at VNMKV Parbhani

Dr. V.D. Patil, Associate Dean of the agricultural college at VNMKV Parbhani, recently visited the farmer training centre GVT Krishikul. The GVT team provided a comprehensive overview of the Trust's initiatives, focusing on mass plantation projects. Dr. Patil and his team explored demonstration plots, laboratories, and sections dedicated to entomology, plant pathology, and farming equipment.

The visit also included a tour of areas dedicated to cultivating Banana, Papaya, Mango, Mulberry, Citrus crops, and Jamun, where the team learned about different farming practices and challenges faced by the GVT Krishikul team.

Following discussions with the agronomist team on soil practices, innovations, and strategies to enhance organic carbon levels, Dr. V.D. Patil and his team gained valuable insights into the organic farming challenges encountered at GVT Krishikul.

Need analysis survey visit to Jharkhand

To facilitate the expansion and replication of GVT's model, a needs analysis survey visit was conducted in Parasnath, Jharkhand state, by Mr. Ashish Bujad and staff member Mr. Harshad Dumade. During the visit, they aimed to gain a comprehensive understanding of the area and its current agricultural practices. They visited various government agriculture departments such as KVK Ranchi, the Sericulture Department, Agriculture Department, ICAR Ranchi, and Birsa Agricultural University. Additionally, they interacted with a few NGOs operating in the area, including Siddhayatan Charitable Trust and Rudra Foundation. Furthermore, they met with local farmers, nurseries, and explored the local market to gain insights into the ground reality.

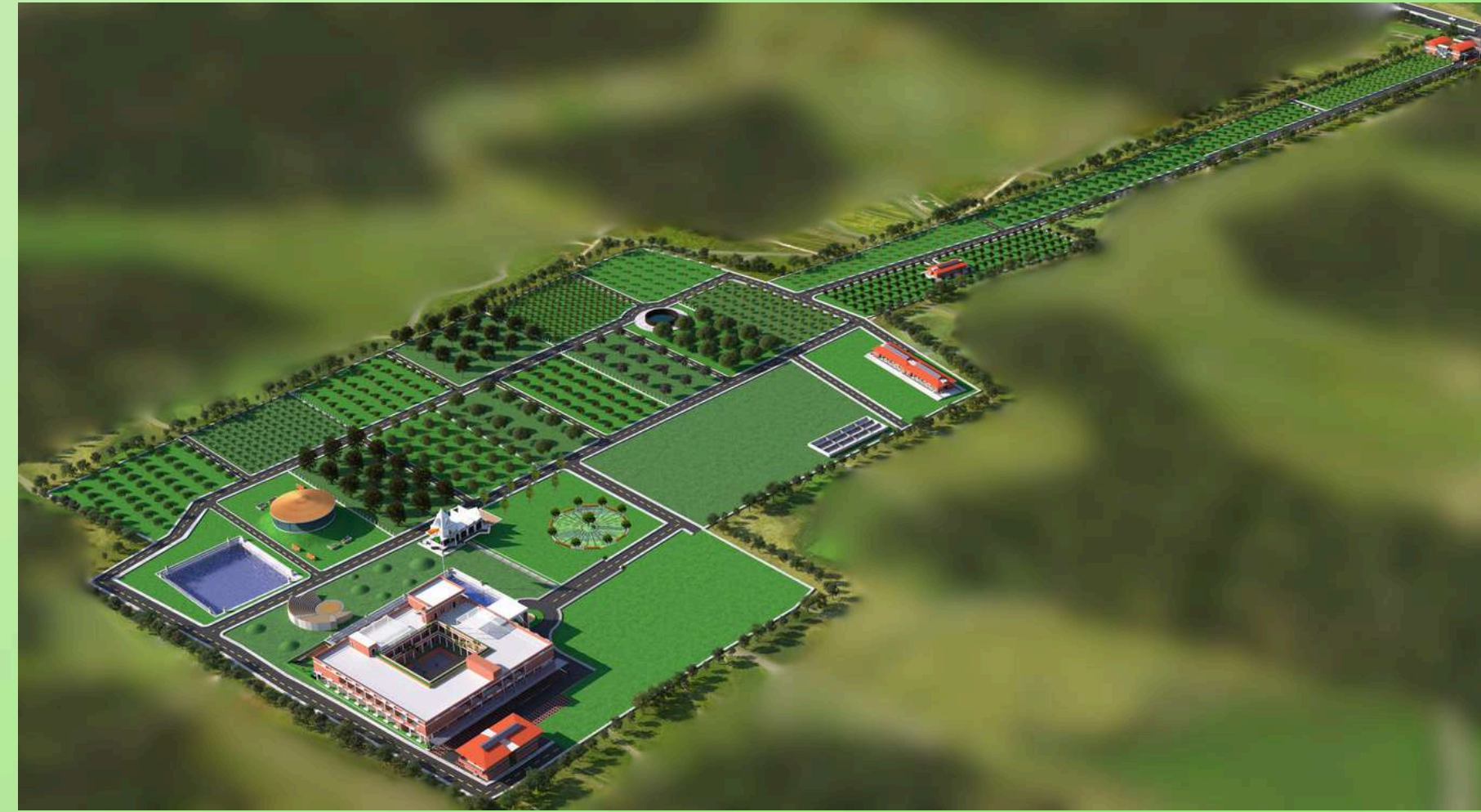


GVT Krishikul

GVT Krishikul is an upcoming farmer training centre and demonstration space to provide practical training and access to modern agricultural technologies. In this series, we are introducing demonstration spaces at Krishikul.

Biogas Unit

Biogas is a renewable energy source produced by certain bacteria breaking down organic matter in anaerobic conditions. The biogas system is where cow dung and urine are mixed with water to form a slurry (raw material for biogas). The slurry is then transferred to the digester (a sealed container that creates anaerobic conditions in which bacteria degrade organic matter), which produces biogas, primarily methane and CO₂. The gas holder collects the biogas. The generated biogas serves as a clean renewable energy source especially for cooking, while the nutrient-enriched slurry becomes valuable organic fertilizer.
